Part		Function
1	Heel Grip	• For re-positioning the Anti-Fatigue Standing Desk Mat
2	Teardrop Flex Center	• For massaging the arches of your foot
3	Raised Side Panels	• For varying your stance
4	Textured Massage Bar	• For calf stretches, core balancing, or foot massages
